The positive trend from the last weeks on all sizes remain unchanged nicely illustrated by the forecast with 5 points up compared to last week now at 396.


Still, the expectations are optimistic as the demand is unchanged high. Also the smaller sizes of 1100-1700 teu participating from the latest market development although with only smaller upward trend as shown on the graphs.

On the other hand it will be interesting to see if we see more demand on these traditional feeder segment after the Easter break as Charterer might be forced to look at smaller solutions for their liner services.

Looking at the latest valuation 1100-1700 TEU moved up but compared to 2016 we still did not reach the rate levels these vessels fixing before. Otherwise on a year to year comparison we see an improvement of 29 per cent on the 2500 teu segment for 24 mos upto close to 80 per cent on the 4250 teu design.
