### **Briefly explain your current role and position.**

*Director at Thurlestone Shipping Australia Pty Ltd, providing dry bulk and sale and purchase ship brokerage services.*

### **When did you begin your career in shipping?**

*I began my shipping career in 1993 sealing hatch covers on steel loaders in Durban Harbour. I went on to then spend 5 years at sea with Safmarine/Maersk, become a Marine Surveyor and then work in P&I Insurance before entering into the Chartering world in 2007.*

### **You became a member in 2013 after successfully completing the Qualifying Examinations. What attracted you to become a member of the ICS?**

*I started studying with the ICS during my time at sea in the late 1990's. Assignments were handwritten in triplicate and posted to the tutor. I suspended my studies to complement them with an LLM in Maritime Law before finally returning to complete my ICS qualifications in 2013. It was important to complete the ICS course and learn more about the finer details of commercial shipping, particularly ship economics, chartering and sale and purchase. I fondly remember my tutors in South Africa all coming from diverse backgrounds in their field of shipping and each contributing to different parts of the coursework. The ICS held interesting, topical and beneficial opportunities to collaborate on the different aspects of ICS coursework. One of the most looked forward to aspects of the ICS year was the annual "weekend away" comprising of a series of lectures for students from across the country to participate and prepare for the annual exams.*



### **For our current and prospective students, what would be your advice in order to be successful in their studies and the exams?**

*Application and interpretation is key. As a shipbroker we tend to be finding solutions to scenarios and interpreting what any given market condition is likely to mean. Applying the coursework to be able to elaborate in context is a skill to be developed during the coursework.*

### **Congratulations on your promotion to Fellow. What does being a FICS mean to you today?**

*As a part of the journey through ICS studies it seemed only appropriate to complete the process. After completing the qualifying exams and then contributing to the ICS as a tutor, fellowship made sense.*
