difficult period for the Institute with his calm, wise counsel and advice. The Institute is very grateful for his exceptional contribution to the Institute.


Kevin Shakesheff FICS becomes the Institute's 58th President in its 110 year history.

ICS Examinations

Unfortunately, the pandemic prevented the ICS from holding examinations in India, Yangon, Bangkok, Dhaka, Antwerp, Montreal, Ottawa, Toronto, and Mauritius – Reduit. Despite the cancellation of these centres, a total of 1,369 examinations were sat around the world in May 2021, comparing favourably to the 1,152 examinations sat in May / July 2020.

More new cranes for Liverpool

The Port of Liverpool has recently welcomed a further arrival of five cantilever rail-mounted gantry (CRMG) cranes as part of the next phase of growth at Liverpool2, the port's deep-water container terminal.

Produced by leading Chinese manufacturer, Zhenhua Heavy Industries Co (ZPMC), the five new cranes are the second of two deliveries in 2021, which will complete the set of 22 CRMG cranes operating as part of the £400 million Liverpool2 project and will provide additional capacity for growing volumes of cargo.

Their arrival coincides with the Liverpool City Region's successful application for freeport status, which will create a further opportunity to position the area at the forefront of the UK's future global trading relationships. Announced by the Government, a free trade zone for the Liverpool City Region will contribute around £850m GVA and create 14,000 jobs, as well as leading solutions to meet local Net Zero Carbon targets for 2040. The bid, submitted last month to government, enjoyed widespread support from the private sector and was supported and formally endorsed by the Liverpool City Region LEP building on the area's maritime history and unique position as a Western-facing port with established Transatlantic and Irish Sea trade links. David Huck, Managing Director, Group Ports said: "While we are only one of the partners in this public and private sector joint initiative, the Port of Liverpool is clearly the largest global gateway to the new regional freeport. How we see our role is helping with wider city region to achieve the greatest possible benefit from its freeport status. "The £400m investment we have made on the Liverpool2 container terminal is a huge enabler. It's the combination of the outstanding facilities here and the freeport status for the region that will really make the difference. "The arrival of the last batch of CRMG cranes at the Port of Liverpool, marks a significant milestone in the next phase of growth at Liverpool2 and reflects the dynamism and strength of our business and skilled workforce. "Peel Ports Group, with its partner global terminal business, Terminal Investment Limited Sarl, is continuing to develop the Liverpool2 terminal to further increase capabilities and support increased demand. Once completed, Liverpool2 will be capable of handling the largest container ships in the world, whilst supporting the UK haulage sector via the very latest landside automated gates and vehicle booking systems. Work on this second phase of the landside project is expected to be fully completed in the summer 2021 and will be supported by the creation of more than 150 new skilled jobs in Merseyside this year. *Source : Peel Ports*

Container shipping could save \$4bn a year from 50% take-up of e-Bills of Lading

Despite this significant cost saving estimated by the Digital Container Shipping Association (DCSA) the adoption of the e-Bill of Lading remains in its infancy. The idea of an a digital or e-Bill of Lading has been around for the better part of 30 years, however, difficulties in moving paper documentation around the world with the onset of the Covid-19 pandemic last year is finally starting to drive adoption in container shipping. Andre Simha, Global Chief Digital and Information Officer for MSC, “The pandemic has brought an urgency to the digital development like the bill of lading as the cargo in ports couldn’t be gated out because paper was stuck somewhere due to air freight delays.

With the world situation it has accelerated the need to digitise these documents. "Even so adoption is still in the early stages and MSC started pilot schemes with a number of customers last year, including D-Well and British Steel. “It seems very simple for people coming from different industries, airlines have managed to make e-tickets and e-boarding passes, banks have had SWIFT for 30 years, but here we are, and we need to find a solution,” said Simha, who is also chairman of the DCSA. “Looking at overall costs it’s estimated an e-bill of lading is roughly three times more economical than a traditional bill of lading. ”But despite the obvious cost benefits, as well as environmental, from not having move documents via air transport the authorities and banks in some countries are harder to be convinced to make the switch. “We are promoting this to the regulatory

authorities and the banks who are the parties being a bit more cautious about this,” Simha said. “Today what we see there are some cases where you cannot use an e-Bill of Lading, there are some countries that will not accept a document which is not on paper and signed and stamped and there we need to put the pressure as well as the import customers to change that.

”So how quickly will change come? While Simha quipped that he’d left his crystal ball in the dishwasher he believes adoption will need to be fairly swift. “I see this happening either relatively quickly, so I think in the next couple of years this needs to change completely, or we’ll have to find another way. With the speed we want to do business today.... it has to change. ”Looking beyond e-Bills of Lading Simha said the industry needed to digitise all the other trade documents it was moving around the world.
