

Very little fixtures to report, little new business to discuss... Fine, we had weeks like this before over the past 12 months but we have to admit to ourselves, that sentiment has changed. The sparse news that we get, do include the one or the other failed fixture. Whilst rates for prompt units are still on a very high level, periods are the battleground, with Charterers trying to pass their uncertainty on to the Owners by way of shorter periods. With no clear direction to be expected we will probably see more of this in the next few weeks....was there something else? Ah yes New ConTex down 1,4%...Happy weekend, enjoy the sun, the rain will come soon enough...guaranteed!
